The ability to claim R&D associated with Subcontracting has recently changed, and HMRC has increased rigour in identifying claim errors, raising the number of enquiries across the board. An upcoming Finance Bill will implement changes in claiming for R&D Tax Relief, such as: new allowable expenses in Cloud & Data costs, overseas subcontracting being ruled out, claims being submitted digitally with a full technical narrative including sign off by a director, and disclosure of the adviser that compiled the claim, together with pre-submission notification to HMRC.
